KCFB Pollinator/Rain Garden receives CAE award

Kane County Farm Bureau's "Pollinator/Rain Garden Public Planting" event was recently chosen by the Bureau American Farm Federation (AFBF) as one this year's County Activities of Excellence (CAE). The annual CAE program recognizes and shares innovative county Farm Bureau programs and activities. For 2020 AFBF chose only 12 County Farm Bureau programs for recognition from submissions across the nation.

The Pollinator/Rain Garden installation was a joint project of the Farm Bureau and the Kane County Environmental and Water Resources Division. In addition to its aesthetic and environmental benefits, the dual purpose (rain garden & pollinator garden) was constructed to remind farmers of their opportunity to install water quality benefits, in lieu of detention, to

meet stormwater management requirements for many on-farm development proj-

ects. The "in lieu of" provisions were a significant and positive change to the Kane County Stormwater Ordinance, approved by the Kane County Board in 2019.

The brisk and bright morning of Friday, October 30th brought Hinckley-Big Rock FFA teacher Tracey Sanderson, students and FFA alumni out for a special event with KCFB Foundation Board President Joe White and Executive Director Steve Arnold.

The group met at the Ag Education Building currently under construction on the east side of Hinckley-Big Rock High School in Hinckley. The shell of the building was constructed over the summer and FFA students and alumni are now prepared for the second phase of cold weather projects including interior construction and instal-

lation of the HVAC system, electricity and plumbing.

The 8:00 a.m. event began with the presentation of a \$500 FFA Chapter Grant from the KCFB Foundation to the high school FFA Chapter. Then, White revealed a second KCFB Foundation check, in the amount of \$20,000, to help in the second phase of construction on the Ag Education building. The 20K amount is expected to cover costs for HVAC and electrical work.

The idea for the building was hatched 5 years ago, when the old building suffered storm damage and community and FFA members and alumni brainstormed the concept of a new building.

building started this past summer, and the shell was built in about four weeks by a team of volunteer laborers and FFA students and alumni. The building construction also benefited from the donation of equipment and personnel.

Sanderson and H-BR FFA Alumni President Nan Long of Big Rock are both impressed by the support in the community and by the enthusiasm of the students for this project. They counted 30-40 volunteers in their core group. Monetary donations from Pioneer, Bank, Compeer Resource Financial, CHS, DeKane Equipment, NIU Board of Trustees member Bob Pritchard and a grant from the DeKalb

preceded the \$20K donation from the KCFB Foundation. They also received site work from O'Donnell Excavating and roofing help from Condon Construction in Sandwich.

Students worked together with adult volunteers, reading blueprints, climbing lifts and learning a lot about the construction process and the collaborative effort needed to construct the building. In addition to the building construction, a group of volunteers provided breakfast, lunch and snacks to the volunteers working at the construction site. "We were well fed," noted Sanderson.

Long commented that "The building shell was built in about four weeks with funding and volunteer labor from the (continued on page 8)

Funding for Farmers Kane County Round 2 Business Grants

On November 19 the County of Kane announced it is now accepting grant applications from FARMS and other local businesses in need of financial assistance due to the COVID-19 pandemic, through "Round Two" of the county's Busi-

ness Grant Program. The Kane County

Board appropriated \$5 million for this initia-

tive from its Coronavirus Relief Fund. Eligible FARMS and other businesses may apply for up to \$25,000 to cover certain expenses from 3/1/2020 to 12/30/2020. (Businesses that applied under Round One are welcome to apply under Round Two.)

Applicants should review the Program Guidelines and Application Instructions for additional terms and conditions. All applications must be completed using the ZoomGrants application portal established for this initiative.

Submissions will be reviewed and funds will be awarded on a first-come, firsteligible, first-served basis. While an application deadline has not been established for the Round Two program, the county anticipates closing the application portal when funds are exhausted, or when it is no longer feasible to process applications and issue awards before the end of calendar year 2020.

More information, including a link to the web-based application portal, is posted on the county's Coronavirus Relief Fund page.

CFAP 2 signup ends Dec. 11

Signup for the Coronavirus Food Assistance Program 2 (CFAP 2) will end Dec. 11. The program provides eligible producers with direct financial assistance due to market disruptions and associated costs because of the COVID-19 pandemic.

Farmers and ranchers who participated in CFAP 1 will not be automatically enrolled and must complete a new application for CFAP 2. To apply, go to *http://farmers.gov/cfap/apply.*

To complete the CFAP 2 application, producers will need to reference their sales, inventory, and other records. However, since CFAP 2 is a self-certification program, this documentation will not need to be submitted with the application. Because applications are subject to County Committee review and spot check, some producers will be required to documentation. provide Producers should retain the records and documentation they use to complete the application.

TARGETED County mini-grants available for Direct farm marketers

Through the "Growing for Kane" program, the Kane County Development Department is administering "mini-grants" to assist farms with COVID related expenditures. These funds are specifically for farms that sell food products direct to consumers.

Information and application procedures on this program, along with a brief survey, will be delivered electronically to those farms identified as meeting the pre-requisite by early December. Farms and farmers that self-identify as meeting the criteria that do NOT receive the information electronically are asked to contact the Kane County Farm Bureau by December 5.

Often referred to as evergreens, Christmas trees include different species of firs, spruces, and pines, all of which stay green year-round. These trees are grown and harvested in 45 different states.

Across the country, over 300,000 acres are dedicated to growing a traditional holiday sight, the Christmas tree. In 2018, more than 32 million Christmas trees were purchased to display in homes and public areas throughout the United States, according to the National Christmas Tree Association. Today, 98% of Christmas trees are grown on farms, and unlike artificial trees made from plastics, real Christmas trees can be recycled to provide benefits to the environment.

A Christmas tree can take up to 15 years to grow to 6 feet tall, so for each tree harvested, Christmas tree farmers plant one to three more seeds. On average, trees are harvested at about seven years old.

3. Now is the fun part! Decorate the snowflakes as much or as little as you'd like using the materials.



Poll shows Americans' unwavering trust in farmers, sustainability

The survey of 2,200 U.S. adults found that more than half (58%) rate the sustainability practices of U.S. farmers positively, with broad agreement from a majority of adults across

Nearly nine in 10 adults (88%) trust farmers, a 4% increase from AFBF's June 2020 polling, which is evidence the public recognized that food supply chain challenges brought on by the pandemic were not within the control of farmers and ranchers.

The survey also explored public attitudes about the envisustainability ronmental achievements of farmers and ranchers, as well as future direction to advance climate-smart farming. Overall, the public agrees farmers shouldn't be expected to bear the financial burden alone. More than four in five adults (84%) say environmental sustainability and economic sustainability are both important for farmers, and most adults say both are very important. More than four in five adults also say feeding the world (84%) and farmers passing farms on to future generations (83%) are important.

"Americans have a high level of trust in farmers, and they understand that we're committed to protecting the soil, air and water," said AFBF President Zippy Duvall. "We want to leave the land better than we found it for our children and grandchildren, as well as our nation. Our survey demonstrates that Americans are impressed by advancements in climate-smart farming and we look forward to building on that success."

Support for farmers' sustainability efforts swelled when government data was shared about achievements. More than eight in 10 Americans (81%) were impressed when they (continued on page 7)





SWEET CHRISTMAS AND CHILDHOOD MEMORIES

grew up in the 60s and 70s in I grew up in the cost in England and America, so my Christmas memories are a patchwork quilt of different customs and celebrations. Through it all, my family was close and we could always depend on each other for support and security. My good home and family is the greatest blessing - it formed the foundation on which I built my life.

One of my fun holiday memories is my mom's annual get together and cookie exchange with her bridge club friends and her challenge to her daughters -"OK girls, I need Christmas cookies!"

My mom was a wonderful, creative cook, but a reluctant, impatient baker. She didn't like following fussy recipes and measuring a quarter teaspoon of this and a tablespoon of that. So she tasked her daughters with measuring and dolloping dough onto cookie sheets, and my younger sister and I had a lot of fun together, thumbing through magazines, finding recipes, making shopping lists, assembling ingredients and turning out dozens of cookies. We would commandeer the kitchen

after dinner with aproned authority and commence to cooking in a flurry of activity, forming a mini assembly line of cookie creation. We had a great time listening to tunes, and gabbing with each other about school and friends and whatever else was on our minds.

As the first batches finished in the oven, warm, buttery smells would waft through the house. My dad would cruise through the kitchen to check our progress and perform quality control on the batches. My brother would make an appearance to "sample" cookies by the handful, drawing protests from his busy baking sisters.

My mom was pleased to present her batch of homemade cookies to her friends and "her" cookies were always well received, which made her proud. In return, my sister and I were able to sample and critique the assortment of exchange cookies. Hey, they were COOK-IES – what's not to like?

I still make cookies at Christmas and send a batch or two to my brother, older sister and niece and nephews in the Seattle area. And my younger

sister and I still get a chuckle out of our mom's "Girls - I need Christmas cookies!" command to us and still reminisce each year about our cookie baking challenges.

Peanut Butter Cookies

1/2 cup butter or margarine

- (1 stick), softened
- 3/4 cup sugar

1/3 cup creamy peanut butter 1 egg

- 1/2 teaspoon vanilla extract
- 1 1/4 cups all-purpose flour
- 1/2 tsp. baking soda
- 1/4 tsp. salt
- 1 cup Reese's peanut butter chips Heat oven to 350°F.

Beat butter, sugar and peanut butter in large bowl until creamy. Add egg and vanilla; beat well. Stir together flour, baking soda and salt; gradually add to butter mixture, beating until well blended. Stir in peanut butter chips; drop by scant 1/4 cupfuls onto ungreased cookie sheet, 6 cookies per sheet.

Bake 12 to 16 minutes or until lightly browned around edges. Cool 1 minute; remove from cookie sheet to wire rack. Cool completely. Makes about 18 cookies.



learned that, according to the Environmental Protection Agency and Agriculture Department, farmers have put 140 million acres in conservation programs, more than doubled the amount of renewable energy sources they use, and nearly tripled the amount of food grown in the last 70 years with the same or fewer resources.

Looking to the future, the survey explores how Americans think sustainability efforts on farms and ranches should be funded. Seventy percent of adults say government incentives to encourage farmers to adopt additional sustainable agricultural practices would be effective. More than three-quarters of adults believe it is important for the government to fund science-based research (76%) and improve infrastructure (78%) to support agriculture.

The survey also revealed there is still work to be done to increase awareness of agriculture's comparatively small contribution to greenhouse gas emissions in the U.S. More than four in five adults (84%) were not able to correctly identify agriculture's impact. On a brighter note, nearly half of adults (45%) correctly ranked agriculture as the smallest contributor to greenhouse gas emissions by economic sector. According to the latest EPA data, agriculture accounts for 10% of total U.S. emissions, far less than the transportation, electricity production, commercial and residential, and industry sectors.




