KCFB scholarships available—application deadline Feb. 15

The Kane County Farm Bureau FOUNDATION is pleased to announce that scholarships are available to members or dependents of members who wish to pursue higher education for a career in an agriculture related field, including a NEW scholarship opportunity for 2021. The applications are for the 2021-22 school year.

College students and high school seniors are invited to apply for these Kane County Farm Bureau FOUNDATION scholarships. Email info@kanecfb.com for an application packet, or, pick one up at the KCFB office, Randall Rd. and Oak Street in St. Charles. A brochure is also available to assist students in identifying potential careers and areas of ag-related study.

Farm Bureau internships are also available for the 2020 winter, and 2021 spring and summer breaks. A separate Internship application is also available. The KCFB FOUNDATION provided 15 scholarships last year and since 1989 has awarded over \$500,000 in tuition assistance to local college students.

NEW – Rodholm Charitable Trust Veterinary Scholarship, up to \$2,000, for an Illinois resident and student

accepted to or enrolled in a School of Veterinary Medicine in the state of Illinois. The

scholarship seeks to help develop the next generation of animal care practitioners.

President's Scholarship (1) \$1,500, reserved for the most outstanding application for a KCFB Foundation General Agricultural Scholarship from among high school seniors, will provide a minimum \$1,500 to be applied towards tuition.

General Agricultural Scholarships (up to 10 available) @ \$1,000, for a KCFB member or dependent in good standing since February 1, two years prior to application deadline. Student must be pursuing higher education for an agriculture related career. A brochure

is available to assist students in identifying those careers and areas of study.

John Buck Memorial Scholarships (2)

@ \$1,500, through an endowment to the Foundation and supplemented by an annual John Buck Memorial Open golf outing, the fund provides for two (2) \$1,500 scholarships for higher education for agriculture students. Students in Kane, DeKalb, McHenry, Boone, Lake, DuPage or Will counties are eligible to apply.

Buck was the founder of Buck Brothers, Inc. and J.W. Turf, both of Hampshire, dealers and distributors of John Deere farm equipment and golf course maintenance equipment, respectively. The family & friends of John Buck established the John Buck Memorial Scholarship for agriculture students through the Kane County Farm Bureau Foundation.

Chuck Swanson Memorial Scholarship (1) @ \$1,000, established by the family and

friends of the former Farm Bureau Director and long-time volunteer, to provide an annual award for a student residing in Kane County pursuing a degree in an agriculture-related career field.

AGCO Global Women's Network (AGWN) Scholarships (2) @ \$1,000, for women residing in Illinois, pursuing degrees in agriculture related career fields. AGCO GWN scholarships are supported by members of the local chapter at AGCO Parts in Batavia.

AGCO Parts Division Scholarships (2) @ \$1,000, for students residing in Illinois, pursuing degrees in agriculture related career fields. Local AGCO Parts division employees in Batavia raise funds to support this scholarship effort.

AGCO Platinum Scholarship (1) @ \$2,500, for an

 lic in advance. The Spree has typically drawn a crowd at the store entrance, making social distancing difficult for spectators and shoppers. Rather, Farm Bureau will work directly with the chosen local officials, the food pantries they represent and a small group of volunteers in 2021 to continue the Shopping Spree tradition, help support area food pantries, and encourage our members to do the same. Originally, KCFB Shopping Sprees marked "Food Check-Out Week," the date in early February by which the average American household had earned enough income to provide for its food supply for an entire year. Typically, consumers spend just 10 percent of their disposable annual income on food. A low number by world standards, thanks to the efficient efforts by America's farmers and ranchers, who work hard every day to provide a safe, abundant and affordable food supply. Farm Bureau still uses the occasion to remind consumers how to stretch their grocery dollars with healthy, nutritious food, and to encourage members and the public to support neighbors in need through local food pantries.

All of the groceries collected during the 5 plus minute spree by each contestant will be purchased by the Farm Bureau and donated to food pantries chosen by the contestants. Most current and former State Senators and State Representatives representing Kane County, going back to 2001, have competed in the event, along with numerous

Mayors and Country Government officials.

Through this and other KCFB sponsored hunger relief efforts, including a 2018 10,000 Gallon milk CHALLENGE, Harvest for ALL and a 2013 Million Meal Challenge, KCFB members have donated the equivalent of more than 2 mil-

lion meals to area food pantries.

Summer Ag Institutes

Kane County teachers will have a unique and exciting opportunity to tour local farms, meet farmers and earn college graduate credits from St. Francis University this summer. Kane County Farm Bureau is hosting its Summer Ag Institute I beginning July 12.

The Summer Ag Institute is scheduled for 4 days, Monday, July 12th - Thursday, July 15th. Kane County Farm Bureau will be the gathering point for teachers to board a bus and tour local farms, agri-businesses and manufacturers, where they will get a clear picture of how agriculture affects our daily lives. The tours

will reveal the essentials of research, production, processing, marketing, transportation and retailing that takes food from farm fields to dinner tables. They learn from farmers, growers, experts in various fields and a crew of dedicated volunteers who share their knowledge and enthusiasm for agriculture, while networking with like-minded peers.

Topics may include GMO's, sustainability, organic practices, local foods, global populations and other current topics in agriculture.

Touch-a-Tractor

Kane County Farm Bureau's

3-day spring open house is a fun opportunity for "city folk" to see antique and new tractors and combines up-close, sit in seats, take photos and mingle with local farmers. Kids will enjoy the many farm-themed activities and games. Touch-A-Tractor is scheduled for April 16-18 on the lawn at Kane County Farm Bureau. Groups and organization that have traditionally provided in-person lessons to 4th graders at the Farm Bureau's "AgDays Expo" at Mooseheart will be issued an invitation to attend Touch-A-Tractor to set-up informational booths and provide education about farms and farmers to families and the public.

FB Foundation to offer community service grants to FFA Chapters

To recognize and encourage the continued contributions of students from Kane County FFA Chapters in the success of Kane County Farm Bureau programs, the KCFB Foundation will offer 2021 incentives in the form of "FFA Chapter Grants".

For many years FFA Chapters assisted the Farm Bureau annually with its largest educational undertaking, Ag Days, where fourth graders gather at the Mooseheart grounds in March for farm-themed lessons. In recent years, individual FFA members have also been crucial to the success of the Farm Bureau's Touch-A-Tractor and county fair promotions.

"We're happy to be able to offer these funds to local FFA Chapters," said Foundation President Joe White. "FFA does a lot for the future of agriculture and the success of young people in all walks of life." He adds, "Their participation in Farm Bureau programs helps FFA members build teamwork, leadership development, and presentation skills while representing their Chapter to the public - and we receive capable volunteers and exposure to the next generation of agricultural leaders."

The Farm Bureau Foundation will renew its pledge to FFA Chapters in return for assistance with four community service, education and promotional programs in 2021 which will promote leadership development skills in FFA members. They are AgDays in March, Touch-A-Tractor in April, the Kane County Fair in July and the Young Farmers Acquaintance program. Participation in two or more of these programs will earn FFA Chapters a minimum

\$250 Chapter Grant. Participation in all four will earn the Chapter \$400. Up to an additional \$100 will be offered to FFA Chapters that complete and report a community service activity, bringing the potential award up to \$500 per FFA Chapter. Chapters will not be penalized for events postponed or cancelled due to the COVID related restrictions.

FFA Advisor Ryan Robinson said the grant will give his students the chance to do bigger projects in the community. "These funds will benefit us in a big way," says Robinson. "This will be a great opportunity to complete a service-oriented activity, such as working with food pantries or sending care packages to troops overseas, which teaches the students good citizenship skills. If we qualify, we would use the grant funds to complete projects with higher costs, such as landscaping projects in the community."

In 2020, the KCFB Foundation provided \$20,000 to the Hinckley-Big Rock FFA alumni to help the group construct and equip an agriculture education building on the school campus, in addition to the district's FFA Chapter Grant.

The Kane County Farm Bureau is a not-for-profit membership organization, representing the interests of local agriculturalists. The Bureau's Foundation provides funding to support agricultural, educational, and leadership development for the benefit of agriculture and local farm families. In Kane County, FFA has three chapters at local high schools in Burlington, Hinckley Big Rock, and Kaneland.

IDOA official: Preparation, patience needed for online pesticide exam

Preparation and patience are Brad Beaver's top recommendations for successfully completing the Illinois Department of Agriculture (IDOA)'s online pesticide certification exam. Beaver, acting chief of IDOA's environmental program bureau, discussed needed equipment and how IDOA addressed issues with the online testing process.

Since mid-December, 780 people completed exams and another 200 exams were scheduled the week of January 11. More than 800 are enrolled in online pesticide training. IDOA expects to offer 15,000 to 20,000 certification exams during the 2021 certification year.

Beaver told FarmWeek IDOA has resolved a problem that caused individuals to be kicked off during an exam. "The main issue was the server wasn't

big enough to handle the (computer) traffic. Things are running much faster," he said.

Beaver recommended someone kicked off during an exam try to log back in and let the proctor know what happened. If that isn't successful during an exam's three-hour timeframe, the test can be rescheduled and \$12 fee transferred to the rescheduled exam, according to Beaver. If a test must be rescheduled within 72 hours, an extra \$12 may be charged to ensure an available proctor.

Beaver noted Google Chrome is the preferred browser and exams should be taken on a desktop or laptop computer either a Windows PC or Mac with a working camera and microphone. Exams cannot be taken on a tablet or Chromebook.

To start, go to the University

of Illinois Pesticide Safety Education website or <https://extension.illinois.edu/psep/training-testing> and follow the step-by-step instructions in figure 1 below to create an account and sign up for any training and any online exams. "Training is valid for 30 days so they can review as many times as needed," he added.

The website instruction page helps users test their computer equipment and microphone. If equipment fails, "you don't have to buy a new laptop or computer. Try to borrow one from someone else," he advised. While a public library computer may be another option, it must be in a private area without others nearby.

If it is difficult to hear using a computer's internal speaker, Beaver recommended connect-

ANHYDROUS AMMONIA

Certified Grower Training

FREE Online Training

www.Bit.ly/IllinoisNH3

All growers or grower farm operators who transport or apply anhydrous ammonia, or otherwise maintain anhydrous ammonia equipment, shall be certified to understand:

- Properties of ammonia.
- Competent in safe operating practices.
- How to take appropriate actions in the event of a leak or emergency.
- Personal Protective Equipment & First Aid.
- Transportation Safety.

Growers and grower farm operators have until April 1, 2022 to be initially certified, and must participate in refresher training every three years.

Certified grower training will be offered at no cost to the grower or grower farm operator via an in-person or online training program approved by the Illinois Department of Agriculture (IDOA).

Online is now available on the IDOA website at www.Bit.ly/IllinoisNH3. In-person training opportunities will be announced as they are developed.

Who needs to be certified?

"GROWER"
Any individual who produces an agricultural commodity on property he or she owns or controls

"GROWER FARM OPERATOR"
An individual employed by or otherwise authorized by a grower to transport or apply anhydrous ammonia, or to otherwise maintain anhydrous ammonia equipment. These individuals include grower family members, full-time and part-time hired help, and others providing anhydrous ammonia services at no fee.

**This new requirement is found in the IDOA regulations regarding anhydrous ammonia at 8 Illinois Administrative Code 215.*



Hello Kane County! The theme for the month of February is Love of the Land. When I dive deeper into what this truly means I couldn't think of a better way to describe it than to recount a conversation with my grandpa. He has been farming all of his life and certainly knows first-hand what it means to love the land. He now farms 1,200 acres of land in both DeKalb and Kane Counties, and I asked him what things come to mind when I say, "love of the land." He started out by explaining how, "A lot has changed over the years. You take good care of the land because you are responsible for it. You must be a good steward of the land." To be a good steward of the land, my grandpa went on to explain that you must be proactive and plan ahead.

My grandpa continued, "You're not just planning ahead for today or this season but for the seasons and generations to come after. Planning ahead means testing your soil to see what the land requires, such as lime, fertilizing, putting in waterways, cover crops, and rotating the fields to keep the

land from eroding from wind and water. Keeping a close watch over your fields for weeds because they will take nutrients out of the soil, which will harm your growing crops." My grandpa went on to explain, "We don't use the same practices that we used back in the day. We don't do the same tillage we used too,



and many farms have moved to no-till. We are much more aware of and do everything we can to conserve the land. Love of the land is being responsible for keeping these things up for generations to come."

After doing all of these practices, my grandpa said one of his favorite things each season is going to the fields in the fall. He explained, "It is so satisfying to combine the beans and watch the golden ears of corn go through the combine – the cul-

mination of another year of love of the land.

When I asked my grandpa what lessons he has learned from loving the land, he responded humbly, "We learn lessons all the time, every day." Many of the lessons my grandpa described revolve around learning from your mistakes, talking to other farmers, and educating yourself about all the different aspects of farm land. Specifically, my grandpa said, "We learn to keep up with what's new, whether it's new technologies, new implementation of practices, and different

machinery, all for more efficient and better farming. If you don't learn, you'll get left behind." My grandpa started farming with just an old tractor, plow, disc, and cultivator. Never did he imagine the advancements or the new discoveries that would blossom in the years to follow.

It's no surprise that farmers work long hours. Oftentimes they work sunup to sundown and sometimes even later into the night. Love of the land means having a good handle on your priorities and getting the family involved at a young age to pass down the knowledge and life les-

sons the farm instills. As my grandparents have always said, "One of the best places to raise a family is out in the country."

One of my favorite take-aways from this conversation with my grandpa was his comment that drove this love of the land home. He said, "If you take care of the land, it will take care of you. Not just for now, but for the generations to come. Think and plan ahead." And I think those words are applicable to not just farming, but to life itself. If you take care of the things you love, they will return that love and care too.

Love for the land, Valentine month and beyond

On a westward drive to the home farm, my eyes drift to the tree-lined grassy knoll atop the Southeast Field. From that hill-top a good half mile off the gravel road, you can take in one of the best views of the home farm. Add in a brilliant sunset, and my heart feels the praise that we vocalize in unison at Sunday worship: God is good.

February brings the month to reflect on love, and a farm family's love for the land proves a unique, powerful, and spiritual bond. While better felt than described, the closest parallel seems a loving parent-child relationship. Farmers often name their fields based on location, size, or ownership lineage. We monitor the land's health and nourish it. We identify its strengths and weaknesses and nurture within its abilities to reach its full potential. Then, we share in the land's accomplishments and failures at harvest.

Spend enough time with the land and you learn where the deer travel, raccoons roam, and bald eagles frequent. The

biggest, oldest cottonwood and sycamore trees stand as landmarks at field edges in the Front Bottom and Fremont East Field. Our kids now fish as we did in the bordering river in the summer and hike the timber for morel mushrooms in the spring. During harvest, they dine on meals in the field and learn to drive tractors. By winter, they beg to sled at the first fall of snow on the soybean stubble at Beecher South.

In time, they will understand how rainwater moves across the land and to use modern precision technologies to implement nutrient management plans. Environmental impact guides our decisions for waterways, conservation practices, and minimum to no-tillage of the soils. Cover crops bring promise to build soil health and nutrient retention. Soil sampling remains a routine standard, something like bloodwork to monitor health. The land's temperature and touch tell its readiness to plant, and a weather-related app on our smartphones tell us the rainfall at each field under our care. Like generations before us, we tend the land with the tools, resources, and knowledge of the time.

The timeless mission remains: Leave the land better than you found it. The mantra resonates across the state and nation, where farmers raise the next generation to love the land and fulfill their duty as temporary caretakers and stewards.

ing external speakers because headphones are not allowed during an exam.

Once an individual signs up for an exam, a time must be scheduled with a test proctor by clicking on the proctor website's link. Testing is "truly available 24/7. If you want to take it at 3 a.m., there's likely a slot available. We've had a lot of people take tests at different hours of the night," he said.

Everyone needs to set up two accounts: one with U of I Extension and another with the proctor service. The same login

and password may be used for both and to schedule additional training and exams.

Those unfamiliar with online proctored exams may be surprised. Beaver explained a proctor will want to "look" at the test taker's room to ensure manuals and other reference materials aren't beside the computer. The proctor will ask to see a driver's license to be sure the person taking the test is the individual who registered. "They will lock down your computer so you can't Google answers," he noted. Likewise, no phone calls or conversations are allowed during the exam.

"Just like when you take the written test, there is a clean desk. We will not let you have your phone and take a call," Beaver reminded.

"The challenge of a remote system is, how can we ensure

the integrity of the exam? IDOA has to comply with U.S. Environmental Protection Agency integrity," Beaver said. "Some may look at this as intrusive, but it's the only way we can be sure."

IDOA staff understand an online testing system is new for some people and allow individuals to have someone with them at first in case there are technical problems, Beaver said. However, once the proctor starts the exam, the additional person must leave, he added.

Nine pesticide training programs were available by Jan. 11 and more are expected soon.

As of Jan. 1, IDOA began offering a few limited in-person testing sessions. The schedule and information is available at https://www2.illinois.gov/sites/agr/Pesticides/Pages/in-person-testing.aspx.

RECYCLING TIPS in the time of COVID-19
Personal Protection Supplies: Gloves, masks, and alcohol wipes can NOT be recycled in your curbside recycling cart. Please check out TerraCycle.org for a PPE Zero Waste Box or dispose of in the trash. Reusable washable masks, gloves, and wipes are a good way to minimize waste.
Delivery Packaging: Most is recyclable, some is not.
Bubble wrap: Bubble-wrap is recyclable at grocery store plastic bag recycling programs but not in your curbside recycling cart.
Cardboard boxes: Remove all packing material from box, flatten box, and recycle in curbside cart.
Plastic pillows or bags: Look for How2Recycle label on packaging, and follow that instruction. Plastic film with a #2 or #4 stamp can be recycled at grocery store programs. Pop the pillows before recycling.
Plastic envelope mailers: Most plastic envelope mailers (with or without bubble-wrap inners) can be recycled through grocery store programs but not in curbside recycling. Remove and dispose of label before recycling, by cutting it off and placing in trash.
Paper envelope mailers: Some are recyclable and some are not. Because there are many different kinds of mailer envelopes, look for the How2Recycle label and follow instructions implicitly. If there is not a How2Recycle label then it is probably not recyclable. The non-recyclable envelopes are generally hybrids of material like the orange-colored paper with plastic bubble wrap inside. Mixed-material items are NOT recyclable. Please throw them in the trash.
Styrofoam: Block Styrofoam is recyclable at the Dart Container Corporation in North Aurora. They will also take cleaned and dried food service foam products.
Take-Out Containers: Many take-out containers are not recyclable. Do recycle clear plastic tub shaped containers (round or rectangle okay) that are bigger than your fist. Do recycled clear plastic clamshell containers. Do not recycle Black plastic. Do not recycle thin, flat lids. Do not recycle foam or small sauce containers.

Private well testing program in February

The Kane County Farm Bureau and Kane/DuPage Soil and Water Conservation District are cooperating again to offer a water testing program in February 2020. A high quality water supply is vital for families, and this program helps provide peace of mind and identifies potential problem areas for homeowners of Kane County.

The program works simply as follows:

Step 1. Monday, February 22 – Friday, March 5, 2021

Pick up water test kits from the Kane County Farm Bureau, 8:30am-4:30pm or from Kane/DuPage Soil and Water Conservation District, 8am – 4:30pm, M-F. Payment is due for each test kit upon pick-up.

Step 2. Sunday, March 7, 2021

Collect the water sample.

Step 3. Monday, March 8, 2021

Return water sample to Farm Bureau or Kane/DuPage Soil &

Water Conservation District. Costs vary for depending on which tests you have performed on your water. Three kits are available:

A. Basic Package (Nitrate Package) – \$45.00

Tests for nitrate, nitrite, ammonia, chloride, sulfate, soluble phosphorus, silica and specific conductivity.

B. Pesticide Screen – \$80.00

Indicates the presence of triazine herbicides, Lasso, Dual or Harness.

C. Metals – \$95.00

Tests for 23 different metals.

More detailed sampling instructions will be included in each kit and additional information on how each test can help you is provided at the Farm Bureau or Kane/DuPage Soil and Water Conservation's District offices. Testing will be performed by Heidelberg College Water Quality Laboratory in Tiffin, Ohio, a

certified lab that has been nationally recognized for its work in testing rivers and lakes, and results are mailed directly to your home. We are able to provide these deeply discounted testing fees because we are providing the laboratory a bulk number to be tested.
