

IFB finds success at AFBF Annual Convention

Illinois agriculture had a strong showing across the convention. Our four Young Leader competitors found success in their events; the organization and three county Farm Bureaus received awards for excellent programming and

member engagement; and a dozen IFB policies were adopted into the AFBF policy book.

IFB policies adopted

IFB delegates always bring strong proposed policy positions to the AFBF Delegate Session, and this year was no exception. All our submittals were approved without much contention, a testament to our grassroots process and the time and effort put into developing policies at the county and state levels.

Adopted IFB policies covered topics Salt Lake City in January. ranging from food access and biofuels to carbon scoring and loan provisions for young farmers. Among them are:

- The new food waste policy from Cook County that was approved at the 2023 Annual Meeting. It supports ways to turn non-consumed food into a resource through composting and reducing the regulatory constraints for on-farm materials, urban food scraps and processing facilities.
- IFB policies supporting ethanol and fertilizer plants converting carbon dioxide into green methanol prod-

ucts and supporting use of the Greenhouse Gases, Regulated Emissions, and Energy Use in Transportation (GREET) model for carbon intensity scoring of agricultural biofuel feedstocks.

An IFB policy that originated from our Young Leaders related to farm credit policy and federal loan programs.

It supports making improvements in all USDA loan programs that include an option to have a six-month pre-approval for a loan and recognizing escalating land and equipment costs when determining the program's loan cap.

Progress on labor and Prop 12

AFBF delegates established positions on some other key issues, including farm labor, Proposition 12 and artificial intelligence.

On farm labor, delegates voted to adopt policy supportive of two priorities: freezing wage rates for guest workers and rolling back the adverse wage rate methodology that was implemented in March 2023. We also discussed policy language related to visa caps, and broadened that language to allow the AFBF board to be accommodating of some concepts. Because the new policy doesn't set a number for visa caps, it allows us

> to have a seat at the table during congressional discussions on potential H-2A and H-2B reform legislation.

> Regarding Prop 12, delegates unanimously approved a Resolution from Iowa Farm Bureau that requests AFBF prioritize and develop a legislative solution to the California provision. I've explained before how this initiative, Massachusetts Question 3 and measures in other states not only undermine interstate commerce and threaten farm profitability, but also erode consumer pro-

tections like food choice and food affordability.

Illinois hog producers are especially concerned about the future and the possibility that other states could regulate how they and other producers market ag products. I'm confident, however, that this resolution will put wind under the sails of AFBF as it seeks and advocates for a solution to Prop 12.

As a Farm Bureau policy geek, seeing the grassroots policy process take its full form at the AFBF convention always reminds me of why I fell in love with this organization: member

voices underpin everything we do. The diversity in ideas and perspectives from around the country is hard to measure, and the passion and patience that come with debating them is just tremendous.

A cord of multiple strands truly is hard to break. Although IFB is strong and we have great influence, our influence is exponentially greater when we combine our voices with Farm Bureau members from other states and focus in on key issues. Those principles anchor our policy book, and I'm proud to represent it.

Long appointed to KCFB Board

Michael Long of Big Rock has been appointed to fill a vacancy on the Kane County Farm Bureau Board of Directors caused by the passing of former Director William Keck. The appointment occurred at the regular meeting of the Farm Bureau's Board of Directors on February 11.

Long was the first nonincumbent Director to declare his candidacy for the upcoming election in May 2024. For that election, the Nominating Committee has proposed a slate of nine candidates, including Long, to stand for election for 3-year terms on the Board. Other candidates will include incumbent Directors Collins, Mike Kenyon, Andy Lenkaitis and Wayne Schneider, and newcomers Long, Russell Flanders, Nick Petit, Trent Pierson and Joseph White. Five will be elected.

Long farms with his father John in southern Kane County. He is the immediate past chair of the Kane County Farm Bureau Young Farmers.

Farmers-enroll for ARC & PLC by Mar. 15

The U.S. Department of Agriculture (USDA) has announced that agricultural producers can now enroll in the Farm Service Agency's (FSA) Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs for the 2024 crop year. Producers can enroll and make election changes for the 2024 crop year. The deadline to complete enrollment and any election change is March 15, 2024.

On Nov. 16, 2023, President Biden signed into law H.R. 6363, the Further Continuing Appropriations and Other Extensions Act, 2024 (Pub. L. 118-22), which extended the Agriculture Improvement Act of 2018 (Pub. L. 115-334), more commonly known as the 2018 Farm Bill, through September 30, 2024. This extension allows authorized programs, including ARC and PLC, to continue operating.

2024 Elections and Enrollment

Producers can elect coverage and enroll in ARC-County (ARC-CO) or PLC, which provide crop-by-crop protection, or ARC-Individual (ARC-IC), which protects the entire farm. Although election changes for 2024 are optional, producers must enroll through a signed contract each year. Also, if a producer has a multi-year contract on the farm it will continue for 2024 unless an election change is made.

If producers do not submit their election revision by the March 15, 2024, deadline, their

election remains the same as their 2023 election for commodities on the farm. Farm owners cannot enroll in either program unless they have a share interest in the cropland.

Web-Based Decision Tools

Many universities offer web-based decision tools to help producers make informed, educated decisions using crop

data specific to their respective farming operations. Producers are encouraged to use the tool of their choice to support their ARC and PLC elections.

Why test your soil?

Soil in its natural state is rarely fertile enough for the best growth of plants. Usually it is necessary to replenish the earth's store of plant nutrients to obtain the most vigorous lawn, the most abundant and brilliant flowers, the prettiest trees and shrubs and the greatest yield of fresh veggies.

Soil test costs

Basic PH Test

\$25 per sample for members, \$35 non-members \$22 Plus members This test checks for soil pH

This test checks for soil pH, phosphorus, and potassium.

Lawn/Garden Test

\$35 per sample for members, \$45 non-members \$32 Plus members

This test includes the basic test plus organic matter and recommendations on amount and timing of fertilizer.

When is the best time to test

Proper sampling is important to obtain accurate results. Samples can be taken any time during the warmer months, when soil temperatures are at

least 55 degrees. If the soil is too wet to spade, rototill or hoe, it is generally too wet to take a sample. On the other hand, extremely dry soil should not be sampled either.

How often should I test?

Ideally, soil should be tested every 3-5 years, more frequently with intensive use. Try to sample during the same season each time for the best comparison.

Why does Farm Bureau provide this service?

Kane County Farm Bureau was founded in 1912 as the Kane County Farm Improvement Association, to help farmers improve their production practices and increase the fertility and productivity of their soil. This program is an extension of that. It helps you take the guess work out of gardening!

Labor, Prop 12 dominate AFBF meeting

Farm labor, Proposition 12 and artificial intelligence were key issues American Farm Bureau Federation delegates established positions on during AFBF's convention in Salt Lake City.

Recognizing the challenges of maintaining a flexible and strong agriculture workforce, delegates voted to stabilize wage rates for guest workers and revise H-2A and H-2B programs to better meet the needs of America's farms.

A lengthy discussion from the delegate floor centered on one piece of language stating: "We may accept visa caps for a year-round program as long as they do not restrict farmers and ranchers from using the visa program and getting their labor needs met." While some delegates were concerned about opening the door for caps, others, including Illinois Farm Bureau President Brian Duncan, said Farm Bureau policy that's too rigid prevents AFBF from having a seat at the table during congressional discussions.

"What the delegates did today is broaden our language to allow the AFBF board to be accommodating of some concepts. The new policy didn't set a number for visa caps, but just said we're open to that discussion that's kept us out of the negotiation room before. Now we can be in the room to talk about that," Duncan told FarmWeek. "And again, we stressed the two priorities that we've identified already: freezing of the H-2A wage rates and rolling back of the adverse wage rate methodology that went into place in March of 2023.

"The delegates really emphasized, and I think streamlined our labor policy, and hopefully positioned this organization better to do good work on behalf of our members around this issue."

AFBF President Zippy Duvall said "no one in this room wants to solve this problem more than I do."

"It's crucial that Congress

pass a new farm bill and address the labor shortage in 2024. The policy set forth by Farm Bureaus in all 50 states and Puerto Rico will guide AFBF in its efforts through the process," Duvall said.

Iowa Farm Bureau also presented a 700 Resolution, which is different than policy but represents a request for a board priority, that emphasizes a request to AFBF to put effort toward a solution to the recently-enacted Proposition 12 in California. The voter-approved initiative, which impacts pork producers across the nation, went into effect starting this year.

The unanimously approved resolution urges AFBF to prevent the "harmful consequences" of Prop 12 and similar initiatives. "The enactment of Proposition 12 and similar initiatives not only undermine the intent of the commerce clause, but they also threaten farmers livelihoods and erode basic consumer protections such as food choice, food affordability and food availability," the resolution states. "A renewed emphasis should be given to a legislative solution that will protect American consumers and farmers while preserving interstate commerce.'

The resolution puts "wind under the sails" of AFBF, Duncan said from the delegate floor.

"Hog producers in Illinois are concerned about the future," said Duncan, who also is an independent pork producer. Prop 12 is dangerous because of the potential for states to regulate what other states do. "It would make it impossible to market our products."

IFB also was supportive of a 700 resolution submitted by the Ohio Farm Bureau on renewable energy, which states: "Considering the difficulties surrounding land use management and preserving farmland, we request the AFBF review federal green energy policy, including commercial solar projects, as it

relates to farmland impact and reliable power generation, supply and grid reliability."

IFB Vice President Evan Hultine spoke from the delegate floor, noting this is a hot topic as it relates to private property rights.

"Anything we can do to bring some balance and understanding to the issue...," he said.

On foreign investment, delegates added policy in support of additional funding to improve data collection on the foreign ownership of agricultural land. Delegates also voted to support the Committee on Foreign Investment in the U.S. reviewing foreign investments in U.S. agribusinesses, natural resources and real estate.

"I think having accurate data is key when we make any decisions," Duncan said.

Delegates also approved:

- New policy to address the growth of artificial intelligence in agriculture. AI has the potential to enhance farming practices and conserve resources, but privacy rights must be respected.
- Reaffirming AFBF's support for increasing reference prices in the farm bill and maintaining a strong crop insurance program, including an expansion of eligibility to ensure more commodities are covered.
- Adding policy to recommend Congress investigate fertilizer supply chain outages and tariffs placed on imports.

Duncan, a self-proclaimed "policy geek," said seeing the grassroots efforts from the county level to the national level is why he fell in love with Farm Bureau.


"There's strength in numbers," Duncan said. "Yes, Illinois Farm Bureau is strong, and we have great influence. But when we combine our voices with Farm Bureau members from other states, and we focus in on key issues, our influence is exponentially greater."

AG LITERACY CORNER

Hello Kane County!

As we celebrate National Agriculture Week and National Agriculture Day later this month, I think there is no better time than now to reflect on and appreciate the influence of agriculture in our daily lives, today and every day.

It can be easy to take both farmers and the professionals in the field of agriculture for granted. We all get caught up in the hustle and bustle of our own lives. 
Book of the month

Kane County teachers have a unique and exciting opportunity to tour local farms, meet farmers and earn college graduate credits from St. Francis University this summer. Kane County Farm Bureau is hosting its Summer Ag Institute beginning June 10.

The Summer Ag Institute is scheduled for 4 days, beginning on Monday, June 10, 11, 12, and 13 from 8 am to 4 pm each day. Kane County Farm Bureau is the gathering point for teachers to board a bus and tour local farms, agri-businesses and manufacturers, where they will get a clear picture of how agriculture affects our daily lives. The tours will reveal the essentials of research, production, processing, marketing, transportation and retailing that takes food from farm fields to dinner tables. They learn from farmers, growers, experts in various fields and a crew of dedicated volunteers who share their knowledge and enthusiasm for agriculture, while networking with like-minded peers.

Topics may include GMO's, sustainability, organic practices, local foods, global populations and other topics that are current in agriculture today.

Illinois' specialty farmers raise a big variety of livestock and crops. There are 612 duck farms, 51 pheasant farms and 142 rabbit farms in Illinois. Illinois crops range much farther than corn and soybeans, including asparagus (153 farms), bell peppers (386), grapes (314), peaches (278) and tomatoes (619).

Snack on seasoned prefzels

Celebrate National Ranch Day with this Young Farmer inspired social snack that will sure be a hit at your next gathering!

Ingredients

12 oz bag honey wheat pretzels twists (or any pretzels of your preference)

1 stick or 8 Tbsp butter melted (may sub for olive oil)

1, 1 oz. envelope dry ranch dressing

½ tsp lemon pepper ½ tsp kosher salt

½ tsp garlic salt

 $\frac{1}{8} - \frac{1}{4}$ tsp cayenne pepper

Instructions

Preheat oven to 250 degrees and place pretzels in a gallon Ziploc bag.

In a medium bowl mix together your melted butter, roughly about half of the ranch dressing, and all of the other seasonings. Then add the butter seasoning mixture to the bag and close it up.

Shake and mix around until all the pretzels are coated in the mixture.

Open the bag and add the rest of the ranch mix, close the bag, and shake again.

Dump the pretzels onto a foillined baking sheet and spread them out into an even layer and bake for 20 minutes stirring every now and then to ensure the pretzels get dry and toasted.

Remove from the oven, let it cool for a few minutes, and enjoy!

craft a Soil Sam

This Illinois Agriculture in the Classroom lesson is a fan favorite! This activity is designed to help students deepen their understanding of seed growth by creating a fun character named Soil Sam! Take it a step further and test variables such as light, liquid source (juice, carbonated water, coffee, etc.) that might affect seed growth!

Materials

Potting soil Untreated grass seed Baby food jars Knee-high stockings Water Jiggle eyes

Instructions

Fabric

Using a knee-high stocking, place some grass seeds in the toe where you want the grass to grow. The toe of the stocking is the top of the head for Soil Sam. The grass will look like hair when

it grows.

Pack a handful of soil in the end of the stocking on top of the grass seeds. Make sure the ball of soil is slightly larger than the baby food jar.

Tie a knot in the stocking under the ball of soil.

Completely wet the head of Soil Sam. Place the opened end of the stocking (the bottom of Soil Sam) in the jar filled with water, making sure the head is above the mouth of the jar. The end of the stocking will absorb the water to feed the grass seeds, which will germinate through the stockings. You may have to poke a few small holes in the top of Soil Sam to help the grass get through.

Now decorate! Give your Soil Sam a face!

Water as needed and be sure to cut the grass (hair) and style as desired.

Optional: Will the grass grow better or faster with fertilizers? Try it out. Add different fertilizers to the soil and water to see which grows best!

Families dominate ownership of Illinois farms

I work every day with the people who raised me. Four desks in the farm office provide space for mom, dad, brother, and sister. It's the same crew I sat with at the dinner table in the 1980s. The ones I made memories with on family vacations at theme parks with the fastest roller coasters. The quartet that spent weekend afternoons cleaning field edges and dining on pizza at sundown on Sunday nights.

Relatively speaking, we're among the mainstream. An overwhelming 96% of Illinois farms are owned and operated by families like ours, a statistic worth recognizing in this season that honors National Ag Day on March 19, 2024. Contrary to popular belief, parents, grandparents, spouses, siblings, children, cousins, aunts, uncles and even in-laws make most decisions about how food, feed and fuel are grown. Not faceless corporations.

That's a pleasant surprise to most citizens of the state, according to surveys that show consumers trust family-owned farms but largely believe corporations own them. Motivated to debunk the ownership myth, the Illinois Farm Bureau partnered with the state's commodity groups. Together, they launched the "We Are The 96" campaign a year ago with a bigtime commercial during Super Bowl 2023.



Agriculture Committee updates

The County of Kane is unique among Illinois' counties in many ways, not the least of which is in its attention to and support of Agriculture as a desirable land use in planning and zoning. Unlike Illinois' 101 other counties, the County of Kane has a functioning and active Agriculture Committee, that meets each month to educate, inform and when necessary, take action on issues that affect farms, food and the environment.

Nine of the County's 28 Board members meet the 3rd Thursday of each month at 10 am at the County Administration Building in Geneva. They hear monthly updates from the Kane County Farm Bureau and Northern

Illinois Food Bank as well as County departments including Development and Community Services and Environmental and Water Resources. Various other county departments, businesses and not-for-profits in the farms, food and environment 'space' routinely appear before the committee.

At the January 2023 meeting of the Committee, KCFB presented a draft resolution for the County of Kane to go on record in support of agriculture. The resolution references the County's past support of many agricultural initiatives and land uses, and encourages the newly elected Board and county staff to continue their tradition of

work to support and promote the development of agriculture for the benefit of Kane County and all its residents.

As the proposed resolution makes its way through County Committee in February and early March, KCFB leaders will be available to answer questions of County Board members about the resolution's history and purposes. We hope to see the "PROCLAIMING KANE COUNTY'S SUPPORT FOR AGRICULTURE" resolution presented and approved at the Tuesday, March 14 meeting of the Kane County Board, solidifying Kane County governments role as a ally in and for agriculture.



Illinois Farm Bureau will host a series of two-hour programs focusing on transportation laws and regulations as they pertain to the agricultural industry.

DeKalb County Farm Bureau will host one of the sessions on Thursday, March 14 at 6:00 p.m. at the DeKalb County Farm Bureau in Sycamore.

The Rules for the Road Seminar will cover recent changes, as well as some of the more established but still misunderstood rules. Topics may include

the USDOT Number, UCR registration, Entry Level Driver Training, farm exemptions, and driver's license classifications to name a few. In addition, one of the events will also be broadcast virtually on March 5th at 10 am.
